# Summer – Fall 2023

After a fairly dry winter and now a dry summer, we are certainly feeling the heat!

# **Drought Advisory**

#### Rainfall in PWC is 7"+ below

Every time my two-year-olds start singing "Rain, Rain, Go Away!" I can't help myself from saying "no, we WANT the rain to stay!" The drought has slowly been taking its toll. Prince William County is currently more than 7" below their average rainfall. On August 30, 2023, The Department of Environmental Quality (DEQ) issued a drought advisory for the county, along with several other counties throughout Virginia.

What can you do? According to DEQ, "All Virginians are encouraged to protect water supplies by minimizing water use, monitor drought conditions, and detect and repair leaks." Though these are things we are already doing, they're important more than ever.

# **Drought Advise for Livestock**

Even if your pastures are in good condition, start feeding hay now! An Important Message from Dr. Fike, VCE Forage Specialist:

The call to stockpile may seem off base when conditions are dry and grass is limited, but it's important to know that resting pastures now is essential for their quick recovery when the rains do return. Some of you may recall we had a very dry fall a few years ago, but we got moisture starting in October. Those who'd stayed off the grass saw rapid growth and reasonable productivity/ recovery. It is essential to rest pastures now and feed hay, as well as keeping a watchful eye on the bottom 10% of your herd.

### Drought damage on your farm?

If you are seeing drought damage on your farm, whether it be crops and/or forage, please contact Thomas Bolles, our Associate Extension Agent with Virginia Cooperative Extension for Prince William County: tbolles@pwcgov.org. The more data we get on the effects of our drought conditions, the better prepared we'll be in making a drought declaration.

### **Our Land use Changes and Water Quality**

Land use in Virginia is fast changing as a result of human development. The greater population of Northern Virginia depends on surface water as the main drinking water source. A greater portion of Prince William County drains into the Occoquan River. This river also harbors the Occoquan Reservoir, which is the main drinking water source for both parts of Prince William and Fairfax Counties.

# How can you promote clean water in Prince William for the next generation?

Volunteer with the Conservation District's Water Quality programs, of course!

 The Chemical Monitoring program supports the Department of Environmental Quality (DEQ) through the Chesapeake Bay Monitoring Cooperative (CMC) with professional chemical data on conductivity, pH,



turbidity, temperature, and dissolved oxygen (tier II) from any location of choice.

- The Biological Monitoring program promotes community science, supports personal projects, and help students gain community service hours. This program provides an outdoor biological field experience and samples benthic macro invertebrates that determine the quality of local streams.
- The Adopt-A-Stream/Pond program allows individuals, families, or groups to promote environmental stewardship in the community through streams/ponds cleanup events supported by the Conservation District.

### **Conservation Plans**

#### **Free Service for Farmers!**

Did you know that the District can provide a free Conservation Plan for your farm if it is located in Prince William County?

If you did know about conservation plans, did you know you can get a renewal every 3 years?

If you've never heard of a Conservation Plan, it is a voluntary plan written specifically for your farm. The District has been writing conservation plans for Prince William County farmers since 1998.



**Every Conservation Plan includes:** 

- maps of your property (e.g. fields with acreages, topography, soils, hydrology, Best Management Practices, etc.)
- Nutrient Management Plan (includes soil test results)
- Yields
- Prescribed grazing plan (for livestock)
- Supply/Demand spreadsheets (for livestock)
- And more!

We'll meet with you on your farm to get an idea of your goals and objectives. Then we'll take soil samples and write a conservation plan that's specific for your farm! This conservation plan is completely voluntary. It is written to not only protect our soils and water, but also to save you time and money!

Program Year 2024 is now open! If you've been in agriculture production for the past 3 years and you have/had a water quality problem on your farm, such as:

- Livestock has/had access to a water body
- No cover crops when main crops aren't growing
- No proper manure storage
- Etc.

then contact us to see if you qualify for cost-share! We have cost-share practices that cover a variety of things such as:

- Stream crossings
- Frost-proof automatic waterers (including pipeline)
- Buffer fencing (to keep livestock out of waterways)
- Buffer fencing already installed
- Winter Cover Crops
- And more!
